

California Privacy Notice

Notice to California Residents

If you are a California resident, you have certain rights under the California Consumer Privacy Act (CCPA), as amended by the California Privacy Rights Act (CPRA). This section supplements the main Privacy Policy and applies only to individuals residing in California.

1. Categories of Personal Information We Collect

In the past 12 months, we may have collected the following categories of personal information:

- Identifiers: Name, postal address, email address, IP address, phone number, account name
- Commercial Information: Records of products or services purchased, obtained, or considered
- Internet or Other Electronic Activity: Browsing history, search history, interaction with our website or ads
- Geolocation Data: General location based on IP address
- Professional or Employment Information: Job title, company name, industry
- Inferences: Profile reflecting preferences, behavior, or interests

We do not collect Sensitive Personal Information (as defined by CPRA) for the purpose of inferring characteristics without your consent.

2. Sources of Personal Information

We collect personal information from:

- You directly (e.g., when you register or interact with our services)
- Event registrations and trade shows
- Website cookies and tracking technologies

- Our affiliates and service providers
- Public databases and social media platforms

3. Purposes for Collecting Personal Information

We use the collected personal information for:

- Providing and improving our products and services
- Personalizing your experience
- Marketing and promotional purposes
- Event facilitation and networking
- Compliance with legal obligations
- Customer service and technical support

4. Disclosure of Personal Information

We may share your personal information with:

- Service providers and contractors who support our business operations
- Affiliates within the Orazox group
- Third parties in connection with business transfers
- Legal or regulatory authorities if required

We do not sell personal information for monetary value, but we may share certain data with partners for targeted advertising purposes. California residents may opt out of this sharing.

5. Your Privacy Rights (CCPA/CPRA)

As a California resident, you have the right to:

- Know the categories and specific pieces of personal information we collect about you
- Access your personal information
- Delete personal information (subject to legal exceptions)

- Correct inaccurate personal information
- Opt Out of Sale or Sharing of your personal information
- Limit Use and Disclosure of Sensitive Personal Information (if applicable)
- Non-Discrimination for exercising your privacy rights
